Invitation for Bids

Consulate General of India Hong Kong invites Bids / Quotations from reputed Property Management Companies (PMCs) based in Hong Kong with specialization in maintenance of Residential properties for Annual Maintenance Contract (AMC) of 17 Residential Properties (List at Annexure-I) for a period of two years from the date of signing the AMC.

1. Eligibility criteria for bidders:

- The company should have a valid PMC license from the competent local authority for Property Management Services.
- The company should be in operation for more than 5 (five) years.
- The company/ agency should have sufficient number of Property Management staff and supervisory staff for the proper execution of the contract.

- **3. Bid system:-** The company/ agency shall submit its offer in **three separate sealed envelopes**, namely, (a) **First envelope** superscripted "Technical Bid- for Annual Maintenance Contract for 17 Residential Properties of the Consulate General of India Hong Kong for a period of two years", (b) **Second envelope**-superscripted "Financial Bid- for Annual Maintenance Contract for 17 Residential Properties of the Consulate General of India Hong Kong for a period of two years". Both the sealed envelopes shall be kept inside a large sealed envelope, i.e. in a **Third envelope** superscripted as "Tender Quotation for Annual Maintenance Contract for 17 Residential Properties of the Consulate General of India Hong Kong for a period of two years". It should also be superscripted at the bottom left corner with the Full name, Postal address, Fax, E-mail, Telephone number of the bidder;
 - The sealed bid shall be submitted to The Head of Chancery, Consulate General of India, 16-A, United Centre, 95 Queensway, Admiralty, Hong Kong;
 - ii. The bids must be submitted in English.

 - **iv.** The bid may be submitted by Hand in person or by post. The bids by "Fax / E-mail" shall not be accepted;
 - **v.** Bid received after the closing date and time as prescribed in the tender notice, shall **NOT** be accepted under any circumstances;
 - vi. Bid shall be opened on the date and time as given in the tender notice at Consulate General of India, 16-A, United Centre, 95 Queensway, Admiralty, Hong Kong, in the presence of the authorized representatives of the companies, who may wish to attend. Only the technical bid shall be opened on 01.09.2023. Financial Bid will be opened for all those parties who have qualified technically.
 - **vii.** The bid has to be submitted as per the format specified at 'Annexure II & III' respectively;
 - **viii.** The Bidder can arrange for a pre-bid site visit by contacting Mr. Pramod Kumar, ASO (Property) over email property.hongkong@mea.gov.in and see the premises. The Bidders are free to bring technician for studying the scope of work for the civil, electrical and masonry work. The pre-bid site visit can be arranged latest by date 15.08.2023.

4. Mode of Payment:

Payment against bill/invoice shall be released on quarterly basis at the end of each quarter by cheque.

- **5.** The bidder must submit **Performance Guarantee** amounting to 5% of the Annual Service Fee upon signing of the Contract which shall be in the form of Guarantee bond issued by any Licensed Bank in Hong Kong.
- **6.** The bidder must submit **Bid Security** amounting to HKD 5,000/- of the bid amount in the form of Account Payee Demand Draft or Banker's Cheque drawn on any Licensed Bank in Hong Kong with a validity period of forty-five days beyond the final bid validity period.
- 7. Late Penalty/ Liquidity damage (LD) will be levied for every day of delay beyond 30 days in completion of maintenance work from the date of receipt of email from the Consulate directing that the said maintenance work be carried out. The LD amount will be calculated for every day of delay, based on 0.5% per week of delay, with the ceiling amount not exceeding 10% of the bid amount.
- **8.** Consulates reserves the right for canceling the tender at any stage and without specifying any reason for cancellation.
